Cookies and Similar Technologies We Use

Dolphiq BV only uses technical and functional cookies, as well as analytical cookies that do not infringe on your privacy. A cookie is a small text file that is stored on your computer, tablet, or smartphone when you first visit this website. You can opt out of cookies by configuring your internet browser not to store cookies. You can also delete any information previously stored through your browser settings.

Accessing, Correcting, or Deleting Your Data

You have the right to access, correct, or delete your personal data. Additionally, you have the right to withdraw your consent to data processing or object to the processing of your personal data by Dolphiq BV, and you have the right to data portability. You can send a request for access, correction, deletion, data transfer of your personal data, or request to withdraw your consent or object to the processing of your personal data to info@dolphiq.nl. To ensure that the request for access has been made by you, we ask that you include a copy of your identity document with the request, making sure to black out your photo, MRZ (machine-readable zone, the strip with numbers at the bottom of the passport), passport number, and Citizen Service Number (BSN) for privacy protection. We will respond to your request as soon as possible, but no later than four weeks. Dolphiq BV also wants to remind you that you have the option to file a complaint with the national supervisory authority, the Dutch Data Protection Authority, via the following link:
